

**Recreation and Parks Advisory Board Meeting
September 25th, 2019**

The Recreation and Parks Advisory Board met on September 25th, 2019 at the County Office Building's public hearing room 003/004. The meeting was called to order at 7:35pm by board chair Judy Baker.

WELCOME AND INTRODUCTIONS:

APPROVAL OF MINUTES:

Judy Baker moved to approve the June 24, 2019 meeting minutes, Derek Ludlow seconded, all concurred and minutes were approved.

Donald Gerkin moved to approve the July 24, 2019 meeting minutes, Derek Ludlow seconded, all concurred and minutes were approved.

DIRECTOR'S REPORT:

1. **Volunteer Hall of Fame** – This is the last year up to 5 volunteers may be selected for Hall of Fame with limit then decreasing to 3 unless changed by Advisory Board. Nominations received from four (4) recreation councils and one (1) from the Department. Winners will be recognized at the Volunteer of the Year reception on November 5, 2019.
2. **Staff Changes** – Loren Lustig retired after 34 years with the department. His former job has been restructured and we completed interviews last week to fill a new Marketing Specialist position. We have just completed the interview process for the vacant Administrative Assistant position and will be filling that job soon also.
3. **Community Service Work Day** – Wantz Distributors supported a trail work day this week with a donation of over \$4,000 and 80 volunteers. Improvements were made to a new section of trail constructed last year including a 21' bridge, 46 tree & shrub plantings

and a 111' long rock wall to help prevent trail erosion. Commissioner Bouchat participated in the event, using his welding skills for the bridge work.

4. **East Middle School Update** – The Board of Education held a recent work session where they discussed the merits of building a “new” replacement for East Middle at the Kate Wagner Fields or at the current East Middle location. The City of Westminster announced that they would not approve a water allocation for the Kate Wagner location as it is outside of city limits. While no final decision was made, it is appearing more likely that the replacement school may be built at the current location. This would be welcome news for the Westminster Area Recreation Council as the Kate Wagner site in their busiest location for programs and serves as a community park.
5. **Taneytown Land Acquisition** – Last week, the County Commissioners approved the purchase of a 145-acre property located at 5125 Francis Scott Key Highway, north of Taneytown. This acquisition addresses a need for county parkland in this area previously acknowledged in Carroll County’s Land Preservation, Park and Recreation Plan.
6. **Capital Project Update**
 - a. *Sports Complex Lighting* –Commissioners approved contract and preliminary electrical work underway; completion during offseason (prior to March 15)
 - b. *Double Pipe Creek Park kayak launch* – we have received approval from MDE and Carroll County and will begin work this fall and anticipated spring completion
 - c. *Deer Park Expansion & Westminster Veterans Memorial Park* – received planning commission approval; projects will be bid this winter with construction starting spring 2020
 - d. *Deer Park Playground Equipment Replacement* – contract approved; late fall completion anticipated

Tom Long moved to approve funding for all priority 1 requests excluding Charles Carroll (due to no representative in attendance) as well as Westminster Area's priority 2 request for Bennett Cerf Park (in response to field damage from flooding). Tony Rosas seconded the motion, which was unanimously approved.

Derek Ludlow moved to approve Central Carroll #2 priority (soccer goals) and North Carroll #2 priority (soccer goals), Donald Gerkin seconded the motion which was unanimously approved.

Jeff Degitz shared that the next step in this process is to take the board's recommendation to the County Commissioners for their approval of the fund transfers.

VOLUNTEER HALL OF FAME:

The Department received a total of 5 nominations for the Hall of Fame with one being a dual nomination (2 people). The Board decided unanimously to recognize only individual Hall of Fame members and could consider the second individual from the dual nomination next year.

The Board decided unanimously to induct five (5) individuals, this being the last year they could induct that many. Beginning next year, up to three (3) individuals may be inducted.

Derek Ludlow suggested consideration of changing procedure to allow consideration of individuals nominated in past years without requiring a new nomination each year. This will be reviewed for 2020 process at a future meeting.

After discussion, the Board decided to unanimously induct the following individuals into the Hall of Fame in 2019: Cathy Bowman, Gary Davis, Henry Lysy, Bo Yingling and Joe Zentgraf. Recipients will be recognized at the 2019 Volunteer of the Year reception on November 5, 2019 at 6:30 pm at the Carroll Arts Center.
