

MD 26 CORRIDOR EFFORTS

- 2018 Carroll County request to review the 2002 MD 26, MD 32 to the Liberty Reservoir, Corridor Planning Study
- The study team included Carroll County Department of Planning and MDOT SHA
- Study limits: MD 32 to Liberty Reservoir (Oakland Mills Road)


MD 26 TRAFFIC ANALYSIS

- MD 26 currently operates at acceptable LOS
- 2018 AADT 35,000
 - MD 32 to Ridge/Oklahoma Road
 - Drops to 19,000 east of Ridge/Oklahoma Road
- 70% Build-Out:
 - Anticipated around 2040
 - Worst delays, MD 32 and Ridge/Oklahoma Road
- Full Build-Out:
 - Anticipated beyond 2040
 - Full corridor will experience failing conditions during evening peak

- Revising the 2002 Typical Section





Access Management


- Median between MD 32 and Ridge/Oklahoma Road
- Development of an Access Management Plan






Safety & Operational Strategies


- Pedestrian Accommodations
 - 5-foot sidewalk with 3-foot buffer
 - Crosswalk Upgrades
 - Conduct a sidewalk feasibility study






Safety & Operational Strategies

- Intersection Operations
 - MD 26 at MD 32
 - MD 26 at Georgetown Boulevard



Future Capacity Strategies

- Auxiliary Lanes, Eldersburg Crossing to Ridge/Oklahoma Road
 - Adding WB MD 26 through/right-turn lane
 - Converting EB MD 26 right-turn lane




