CALL TO ORDER:

Meeting was called to order at 8 a.m. by Chairman Paul Noyes at Carroll County Public Training Center, Westminster, MD.

The minutes of September 23, 2020 were emailed to each board member. Mr. Noyes asked the board if everyone had read the minutes and had any changes. Mr. Brosenne made a motion to approve the minutes as written. Mr. Sullivan seconded the motion and was unanimously carried by the Board.

OLD BUSINESS;

Adopting 2020 Codes

Mr. Darrell Zepp referred to his handout with the breakdown on the estimated cost if adopting the 2020 codes for the Boards input. Mr. Brosenne made a motion to move forward with Adopting the 2020 Codes. Mr. Sullivan seconded the motion and was unanimously carried by the Board.

Journeymen License

Mr. Darrell Zepp discussed that both Montgomery and Harford County have a Journeymen license. Montgomery and Harford require the individual on any jobsite or any electrical project to either have a master electrical license or a journeymen license. The master license may have as many workers as needed under his supervision on the jobsite or a journeyman can be on site with five (5) workers under his supervision. If the number of workers exceed five (5) another journeyman must be on site. However, Harford County has no limit to the number of individuals working under the supervision of the journeyman. Mr. Brosenne would like Carroll County to offer a journeymen test.

NO NEW BUSINESS:

The meeting was reconvened at 1:00 P.M to grade the Master Electrical Exam. The Board graded the exam. The required score to pass the exam is 70%. Mr. Ryan Dorsey passed the Master Exam with a score of 81% and Mr. Jason Harris with a score of 74%. Seven applicants did not pass the test:
