Subject: 2022 Maryland Medical Protocol Rollout

The Maryland Medical Protocols for Emergency Medical Services (2022 Edition) is now available on the MIEMSS website (<a href="http://www.miemss.org/home/ems-clinicians/protocols">http://www.miemss.org/home/ems-clinicians/protocols</a>).

To assure compliance with the Protocol Rollout prior to the MIEMSS deadline, all EMS clinicians must complete this training by July 1, 2022.

All EMS clinicians should complete the protocol update version that aligns with their level of licensure: EMRs and EMTs should complete the BLS version, CRTs and Paramedics should complete the ALS version.

All clinicians should follow the directions below to complete this training:

- Log onto the MIEMSS Website at www.emsonlinetraining.org
- Log into the system
  - o Username is your 7-digit EMS Provider ID number
  - Password is your MIEMSS Licensure account password
- Use the "Forgotten Username or Lost Password" option under the "Log In" button for login issues.
- Select the "2022 Maryland EMS Update and pick the appropriate update. These are found under the Featured Courses Tab halfway down the page.
- Select "Read More" in the appropriate box for your certification level.
- Next, select the "Enroll Me" button
- Under the 2022 Maryland EMS Update: Course Content; click on all links provided
- Enter the course and complete the modules
- Upon completion of all modules, you must take the Course Quiz
- You will have an ability to print a certificate at the completion of the update
- Personnel shall then forward a copy of your certification to the EMS leadership within each station.
- EMS Leadership shall forward all copies received to the CCDFEMS EMS Officer for documentation in the clinicians training file.

Please remember to complete your update before the deadline.

The Maryland Medical Protocols for Emergency Medical Services (2022 edition) is now available on the MIEMSS website (<a href="http://www.miemss.org/home/ems-providers/protocols">http://www.miemss.org/home/ems-providers/protocols</a>). The protocols will go into effect on **July 1, 2022**.

There are multiple evidence-based updates to the protocols this year. We have added new medications and procedures, revised indications for others, and removed a few procedures as well. As a reminder, if you are using the electronic version of the protocol document, you may click on any italicized word to go to relevant medication and related protocol pages. There is also a "Back to Contents" link located at the bottom of each page.

This year's protocol video updates have been posted to the MIEMSS Online Training Center (links below). EMS clinicians should complete the protocol update version that aligns with their level of licensure: EMRs and EMTs should complete the BLS version, CRTs and Paramedics should complete the ALS version.

Regardless of how each clinician views the video content portion of this year's update (Online Training Center, YouTube, company drill format), every EMS clinician must log in to the MIEMSS Online Training Center and complete the quiz portion in order to obtain credit for the required course. Please remember to complete your update before July 1, 2022.

For EMS base stations, the video update is available on the MIEMSS base station website (link below). Hospitals may download the SCORM file from this site, if desired. Importantly, each base station coordinator must maintain learning management records or signed and dated attestation forms that reflect update completion for all base station physicians and nurses.
