The Recreation and Parks Advisory Board met on March 28, 2018 at the County Office Building's public hearing room 003/004. The meeting was called to order at 7:30 p.m. by board chair Anthony Rosas

WELCOME AND INTRODUCTIONS:

APPROVAL OF MINUTES:

John Marks moved to approve the March 28th, 2018 meeting minutes, Donald Gerkin seconded, all concurred and minutes were approved.

DIRECTOR'S REPORT:

- <u>Piney Run Heron Sculpture</u> Unveiling held on April 12 with over 100 people in attendance; special thanks to Board members Judy Baker, Mike Rodgers and John Marks who attended and Piney Run Staff for their efforts
- 2. <u>Charles Carroll Community Center</u> building has been taken down; design proposals due to County May 25
- 3. <u>Bruce Dutterer Golf Tournament</u> Rescheduled due to last week's rain; new date Saturday June 30 at Oakmont Green; registration open
- 4. <u>Employee Service Awards</u> Commissioners recently recognized county employees for service time; Recreation and Parks recognized Katy Bassett and Lisa Carroll for 5 years, Becky Kishter 10 years, Nikki Wolf 15 years and Matt Purkins 20 years
- 5. <u>Bennett Cerf Park</u> Bridge to dog park damaged during delivery of mulch and is unusable; effort underway to replace bridge as funding was already included in FY 2019 budget; working with Random House to allow for dog park access during closure
- 6. <u>Springdale Preparatory School</u> School is renting former New Windsor Middle School site and we have submitted a draft joint use agreement for consideration to allow for community usage by recreation council; this document would formalize what is currently happening on site
- 7. <u>Youth Fishing Tournaments</u> April 29 at Westminster Community Pond with 238 registered and May 20 at Krimgold Park with 59 participating

8. July is Recreation and Parks Month – Theme for this year is A Lifetime of Discovery; this year's efforts will include a Commissioner Proclamation, Park Pursuit's A-Z Calendar (to be published in June) with giveaways and end of month party

Budget Update:

- One new FT position in department Chief Range Officer at Hap Baker Firearms Facility; position replaces 40 hour contractual position with regular FT with benefits; funded by enterprise fund
- New FT Manager position for NCHS site not funded
- \$330,000 added by Commissioners to Public Works budget last year for parking lot paving at Landon C Burns, Bennett Cerf and Deer Park; to date, Landon C Burns has been completed
- Discussion re: turf field and leaving \$500,000 funded last year in place for now but may reconsider if additional community support does not happen soon
- FY19 capital projects funded include Bennett Cerf Park bridge repairs \$205k, Charles Carroll Tennis/Basketball courts \$121k, Deer Park Phase II \$250k, Double Pipe Creek Park boat ramp design \$32k, Freedom Park play surfacing \$75k, NW Trail acquisition \$200k, trail development \$50k, park restoration \$167k, tot lot replacement \$78k and Westminster Veterans Memorial Park \$250k

Capital Preview & Discussion

- Possible projects include:
 - Maintenance of park infrastructure
 - BBNC Pavilion replacement
 - Deer Park field lighting renovations
 - NCHS field lighting renovations
 - Old Liberty Road parking lot paving
 - New Projects to meet growing needs
 - Northwest rail trail design and construction
 - Adult fitness equipment at Westminster Community Pond
 - Request for other suggestions from Advisory Board no additional project ideas brought forward

Self Help Policy Discussion

- Quick review of policy (Sept & Feb requests, \$20k project limit, requests must be sponsored by recreation councils, recent addition of quasi-public sites such as Lions Club, etc.)
- Possible changes to policy:
 - Increase project dollar limit to \$25k
 - If a- joint use agreement is in place that ensures public usage of facility, should Springdale Preparatory School be considered an eligible site?

Judy Baker moved to increase the self-help policy project limit from 20K to 25K and add wording to the policy stating 'if joint use agreement is in place between Recreation & Parks and a non-public facility the local recreation council may apply for self-help funds for that facility.' John Marks seconded, all were in favor and the motion was approved.
